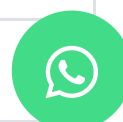
**iii) Multiple-entry:** Offers multiple entries throughout the visa's validity, adhering to the 90/180-day rule.

## Schengen Visa Documents Requirement

**Schengen Visa Application Form:** Filled out accurately and signed.

**Valid Indian Passport:** With at least three months validity beyond your intended departure from the Schengen Zone and two blank pages for visa stamping.

**Recent Passport-Size Photographs:** Two identical photos meeting Schengen photo specifications (35mm x 45mm, coloured, light background, neutral expression, full-face view).

**Travel Insurance:** A minimum coverage of €30,000 for medical emergencies throughout the Schengen Area.

**Proof of Accommodation:** Hotel bookings, hostel reservations, or a letter of invitation from a host in the Schengen Zone.

**Proof of Financial Means:** Bank statements, salary slips, or sponsorship letters demonstrating sufficient funds to cover your stay.

**Round-Trip Flight Booking:** Confirmation or itinerary with your entry and exit dates from the Schengen Zone.

**Leave Letter from Employer** (if employed).

**No Objection Certificate** from School/University (if a student).

**Proof of Civil Status (if applicable):** Marriage certificate, birth certificate.

**Visa Fee Payment Receipt.**

### You can submit your application at:

The embassy or consulate of your destination country in India.

A VFS Global centre in Bangalore, Chennai, Mumbai, or Kolkata (if available for your destination country).

### Scheduling Your Appointment

Contact the embassy/consulate or VFS centre to schedule an appointment.

Be prepared to provide your personal and travel details during scheduling.

Confirm your appointment a few days prior.

## Schengen Visa Processing fees

The standard visa fee for adults is **€80, and €40 for children aged 6-12**. However, fees may vary slightly, so check with the embassy/consulate.

## Schengen Visa Validity

**Schengen Visa Type C (Short-Stay Visa):** This is the most common visa for tourism, business trips, or short visits. It permits a maximum stay of 90 days within any 180 days. This is often referred to as the 90/180-day rule.

**Visa Validity Period:** The specific timeframe you're allowed to stay in the Schengen Area will be clearly stated on your visa sticker under the section "**Duration of Visit.**" This period can be less than 90 days, depending on the issuing embassy/consulate and your specific travel plans.

**Multiple Entries:** Even with a multiple-entry visa, the 90/180-day rule applies. You can enter and exit the Schengen Zone multiple times within the validity period, but the total number of days you stay cannot exceed 90 days in any 180 days.
