Strategy Proposal	Report including sections: (a) Background and context of the organisation (b) Position Statements (c) Strategic Aims and Priorities (d) Implementation Approach (e) Measuring Success	The combined recommended word count range for the strategy proposal is 3500 – 4500 words. The learner will be required to complete several tasks to support the completion of the written strategy proposal and presentation. These should be evidenced as appendices within the strategy proposal. There is no word limit on the appendices.
Strategy Presentation	Presentation followed by assessor Q&A	The time limit for the presentation is 15-20 minutes There will then be a maximum of 10 minutes allowed for follow-up questions on the strategy proposal
