### How long you can stay in Canada on Visitor visa?

Most visitors can stay in Canada for up to six months.

You can stay longer or shorter than six months at the border services officer's discretion. If that's the case, your passport should indicate the date by which you must leave. A Visitor Record may be offered to you that confirms the departure date.

Those without passport stamps, they can stay for six months following the date they arrive in Canada or through the expiration date of their passport. The border services officer can provide you with a stamp if necessary. You can ask an airport's border officer once you've completed the primary inspection kiosk.

Make sure you need a visitor visa before you apply

#### A visitor visa or an ETA(Electronic Travel Authorization) may be required. It depends on the following factors:

- 1. Travel type and travel documents.
- 2. Your passport's issuing country.
- 3. The nationality you hold.
- 4. The method of travel you will use to reach Canada.

### 2. Australia

A Visitor visa is also known as a temporary visa in Australia. This visitor visa can be applied for several purposes like

- 1. Visiting friends and relatives
- 2. Tourism except for business or
- 3. Medical treatment.

#### How long you can stay in Australia on vistor visa?

You can Stay up to 12 months continually or a total of 12 months in any 18-month period.

Using this visa, you can spend a total of 3 months studying or training abroad. Nonetheless, if your primary reason for traveling to Australia is to study, a student visa may be more appropriate. You can't work.

It is a temporary visa. Depending on the letter of the grant, you can stay for the period or dates specified. Depending on your situation, the Australian Government, Department of Home Affairs determines your visa's duration. The following are some points you might consider when deciding how long to stay:

What is your desired length of stay. Your reasons for staying in Australia. You might not be allowed to stay as long as you would like.

The visitor visa in Germany, also known as Schengen tourism, allows its holders to travel and visit their friends and family in the Schengen area.

## How long you can stay in Germany on Visitor visa?

On a German visitor visa or Schengen visa, you can stay up to 3 months (90 days) within a 180-day (6 months) period for business, visitor, or tourism purposes.


